CONSUMER CONFIDENCE: TURNBULL TURNAROUND

- Consumer confidence fell 1.0% in the week ending 3 April after a fall of 1.6% over the previous two weeks. After being on an upward trend for the past eight weeks, the four week moving average is now falling. Driving the fall was weakness in confidence in the economic outlook. In contrast, households' views of their own finances improved over the week.
- Consumers' views around the five year economic outlook fell a sharp 7.6%, while views toward the one year economic outlook declined 0.8%.
- Consumers' views towards their current finances rose a solid 2.6% ('finances compared to a year ago') and views towards future finances nudged up 0.2% ('finances in the next 12 months').

ANZ HEAD OF AUSTRALIAN ECONOMICS FELICITY EMMETT COMMENTED:

"Confidence has fallen in the past three weeks following recent highs. Disappointing news flow around the economy seems to be creating uncertainty about the economic outlook for households. Employment growth has slowed, retail sales have disappointed and house prices have softened.


Moreover, government machinations in the lead-up to the Commonwealth Budget may be weighing on the outlook for households. With the Coalition now behind in the polls and Prime Minister Turnbull's personal ratings falling, optimism over the potential for the current government to implement lasting reform seems to be fading."



FIGURE 2. CONSUMER CONFIDENCE HAS FALLEN 2.6% OVER THE PAST THREE WEEKS...






FIGURE 4. CONSUMER CONFIDENCE VS GOVERNMENT CONFIDENCE

FIGURE 5. CONFIDENCE IN THE FINANCIAL SITUATION REMAINS ELEVATED...






